
Think about the services that are important to you – from the type of coffin you want – to whether you need a limousine for family or friends.

Golden Charter plans fix the cost of our professional services included in your plan at today's prices - guaranteed. What can't be fixed are third party costs such as cremation, burial or officiant fees (see our table below). As third party costs are outside of our control but need to be paid for at the time of the funeral, our plans include an allowance towards these costs based on your choices. The value of the allowance may grow over time. There will only be more to pay at the time of the funeral if the third party costs exceed the allowance when you buy your plan, or if the costs increase by more than the growth of your plan.

How much will my funeral plan cost?

The total cost of your funeral plan is based entirely on the choices you make. Typically, funerals in Northumberland range between £2,285 and £5,600.³ The retail price of your funeral plan is representative of the equivalent cost of a funeral today. Prices are applicable from January 2025 and subject to change without prior notice.

Flexible payment options

Golden Charter offer a range of ways to pay for your plan. You can make a one-off payment for immediate cover or spread the cost over 12 months at no extra charge. For a lower monthly payment, you can choose to spread the cost of your plan between two and 15 years with the instalment payment option. All plans include a one-off Golden Charter arrangement fee of £325 as a contribution towards setting up your funeral plan.⁴ Simply choose the option that's right for you.

SINGLE PAYMENT OPTION

You can make a one-off single payment for immediate cover.

12 MONTHLY PAYMENT OPTION

If you would prefer to spread the cost, you can pay over 12 monthly payments by Direct Debit at no extra charge. You will be covered once all payments are made.

INSTALMENT PAYMENT OPTION

For a lower monthly payment, you can also choose to spread the cost of your plan between two and 15 years. This option includes the added benefit of the Golden Charter Pledge, which ensures that if you die at any time after you have made 12 payments and your payments are up to date, the benefits of your plan will be provided, with no further sums to be paid.


